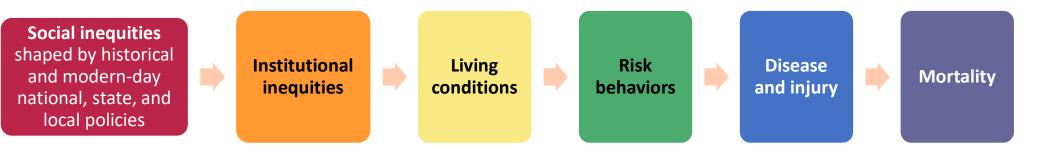

#### Key points

- Disparities in mortality are driven by historical and present-day national, state, and local public policy choices and institutional practices that shape inequities in the conditions in which people live, work, learn, and play in Alameda County. Disparities in mortality are not primarily the result of individual choices or behaviors.
- There was a decline in life expectancy in Alameda County in 2020-2021, during the COVID-19 pandemic. Existing racial and ethnic disparities in mortality and life expectancy increased in 2020-2021 relative to 2018-2019. Disparities in life expectancy by neighborhood poverty level also increased during this time.
- Alameda County's age-adjusted COVID-19 mortality rate in 2020-2021 was less than half that of California and the United States. Alameda County prioritized equitable vaccination and testing and layered mitigation with mask policies during the Delta and Omicron BA.1 surges. We are grateful to the residents of Alameda County for their contributions to protecting themselves and their community.
- There were increases in deaths at young ages in Alameda County in 2020-2021 that mirror increases across the United States. The main causes of increased deaths at young ages in Alameda County and across the United States were increases in unintentional overdose, homicide, and unintentional motor vehicle crash fatalities.
- Chronic diseases remain the leading causes of death among those 45 years old and older in Alameda County, though at lower rates than in California and the United States. Structural inequities have driven longstanding racial and ethnic disparities in chronic disease mortality rates, especially for Pacific Islander and African American/Black populations in Alameda County.

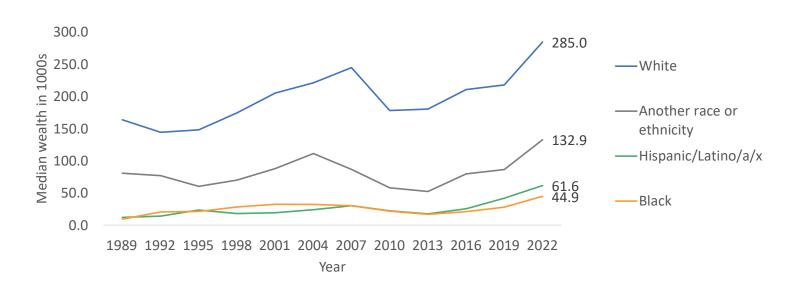

#### Context: Wealth inequities grew during the pandemic

Historical policies and practices have shaped large racial and ethnic disparities in wealth, poverty, and health in the United States and in Alameda County. These disparities shape where people live, work, learn, and play, as well as vulnerability to disasters such as the COVID-19 pandemic.

Median wealth by race and ethnicity in the United States, 1989 to 2022



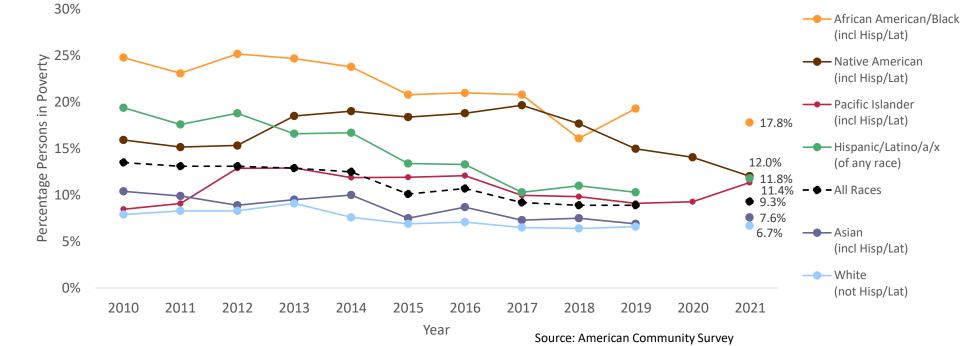
Racial and ethnic disparities in wealth in the United States are large and grew in absolute magnitude from 2019 to 2022

#### Context: Persistent racial and ethnic disparities in poverty

Poverty was on the decline in Alameda County leading up to the COVID-19 pandemic. There was a pause in data collection due to the pandemic in 2020. Then poverty increased in 2021. There are persistent disparities in poverty by race/ethnicity.

Temporal trends in the percent of Alameda County residents in poverty, by race and ethnicity (5-year moving averages for Native American and Pacific Islander)



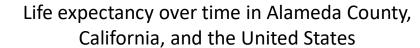

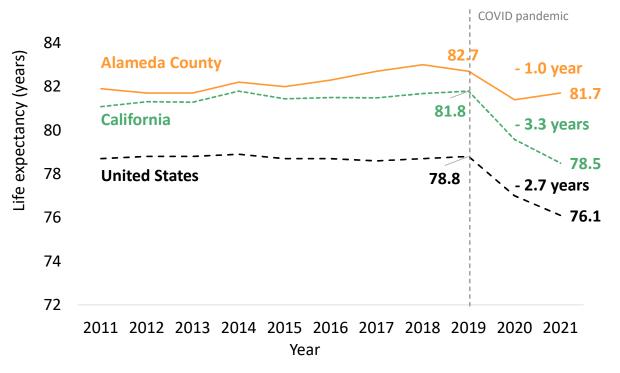
#### Context

- Learning about how mortality changed during the first two years of the COVID-19 pandemic can inform work to improve health and reduce health disparities in times of crisis and in all times.
- As the 2022-2025 Alameda County Health Needs Assessment highlights, there is a need to improve economic security and opportunities, access to care, and community safety to improve health and well-being and reduce mortality.

#### 1. Growing disparities in life expectancy

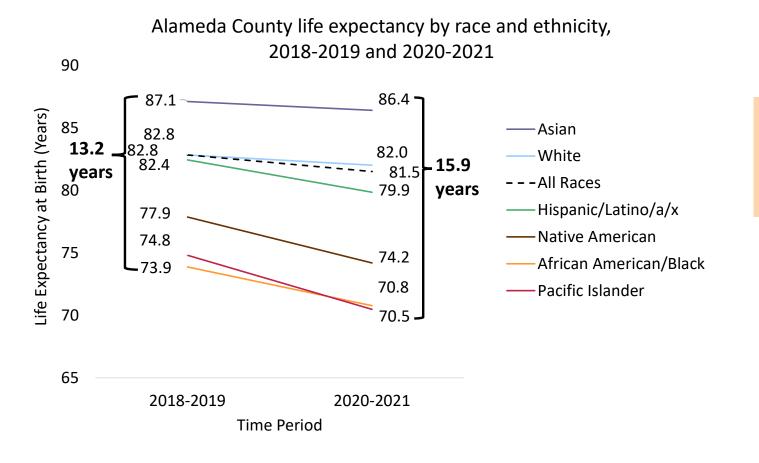
### Alameda County has a higher life expectancy relative to the United States, and experienced less of a decline in 2020-2021





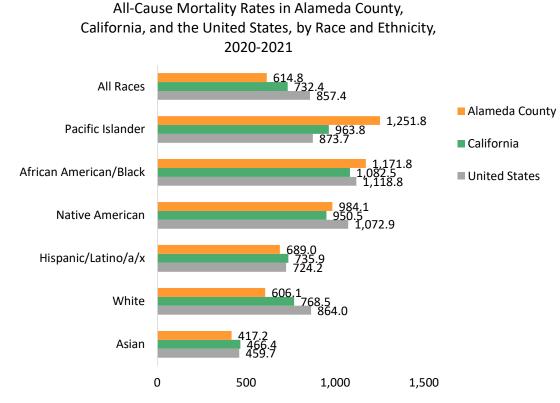
Life expectancy in Alameda County was longer than life expectancy in California and the United States prior to the COVID-19 pandemic. In 2020, there was less of a decline in life expectancy in Alameda County than in California and the United States. While life expectancy continued to decline in 2021 in California and the United States, life expectancy began to recover in Alameda County.

## Already large racial and ethnic disparities in life expectancy grew worse in 2020-2021

## Racial and ethnic disparities in Alameda County relative to California and the United States

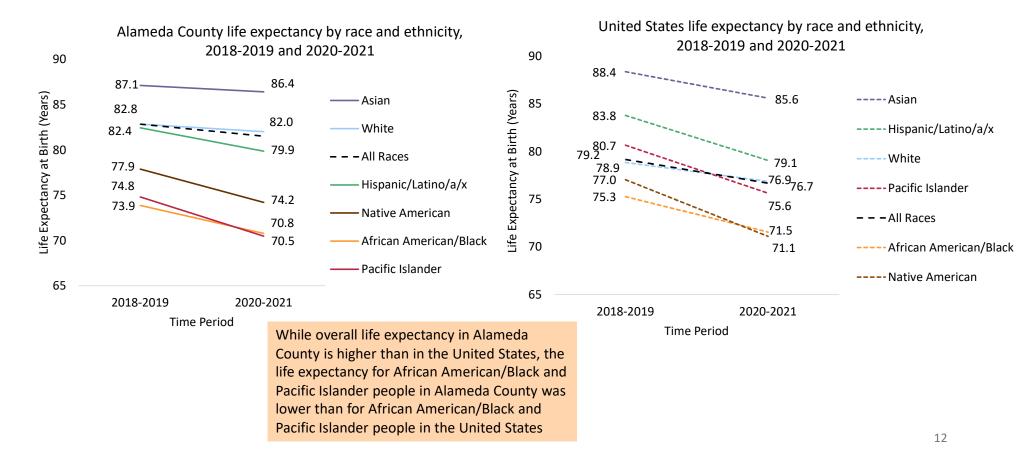


Age-Adjusted Mortality Rate per 100,000 Population

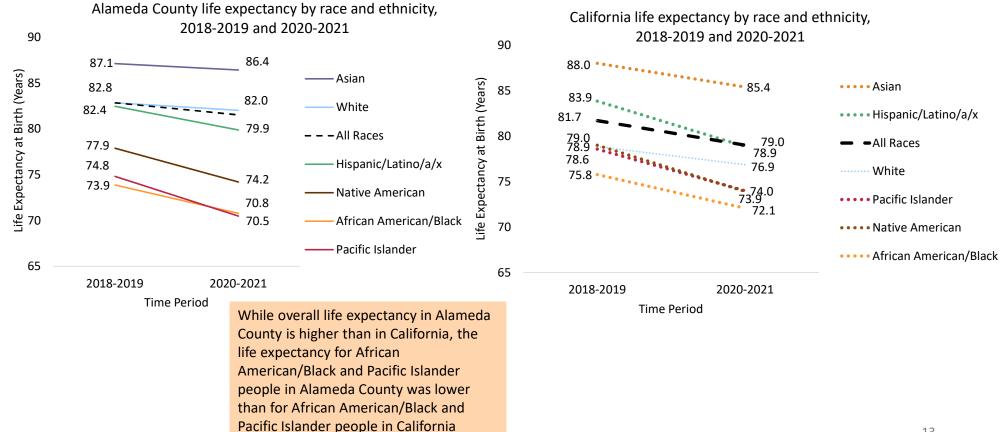

### Life expectancy disparities in Alameda County relative to the United States

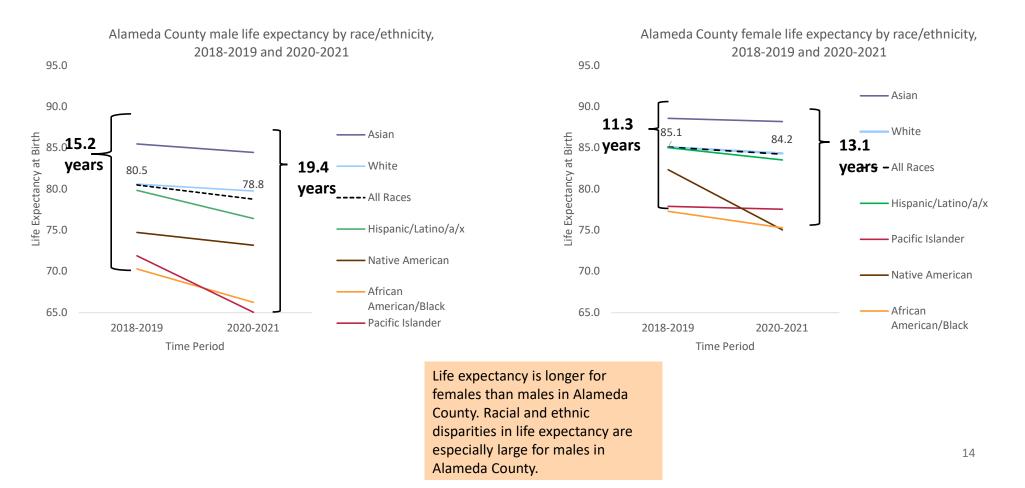


#### Life expectancy disparities in Alameda County relative to California

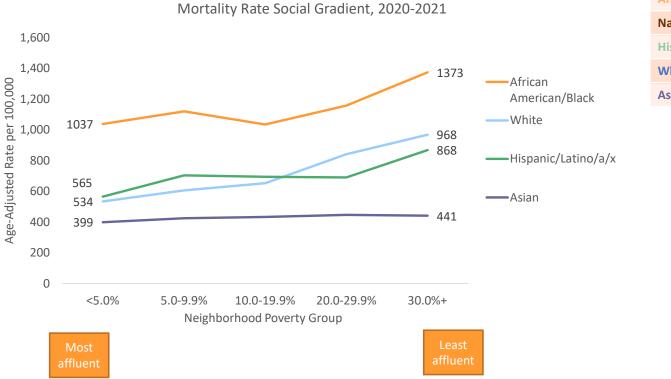

### Racial and ethnic disparities persisted across neighborhood poverty level

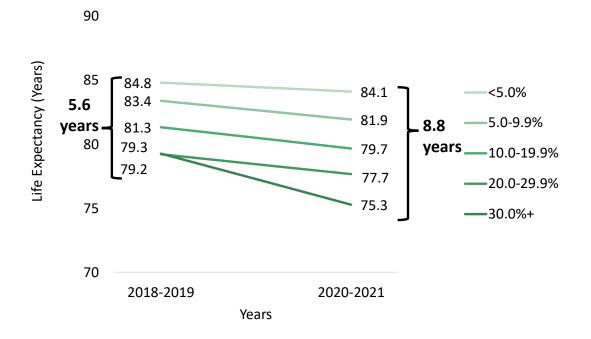

African American/Black people in neighborhoods with high poverty rates experience the worst mortality, but African American /Black people in the lowest-poverty neighborhoods still experience worse mortality than people of other races and ethnicities, even in highpoverty neighborhoods.

Neighborhood poverty is the percent of individuals in poverty by census tract. Native American and Pacific Islander averages are depicted in the table rather than the figure by neighborhood poverty due to small population size.

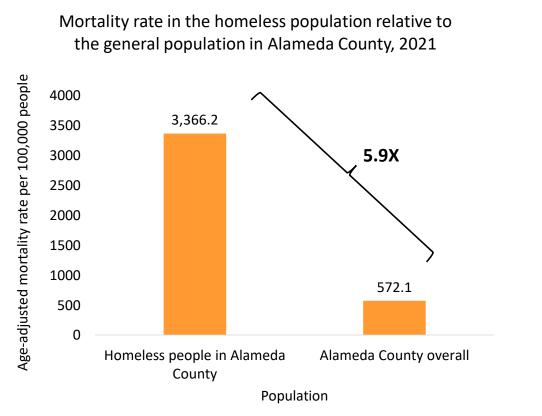
## Disparities in life expectancy by neighborhood poverty grew worse in 2020-2021

#### The mortality rate for homeless people in Alameda County is nearly 6 times that of the general population

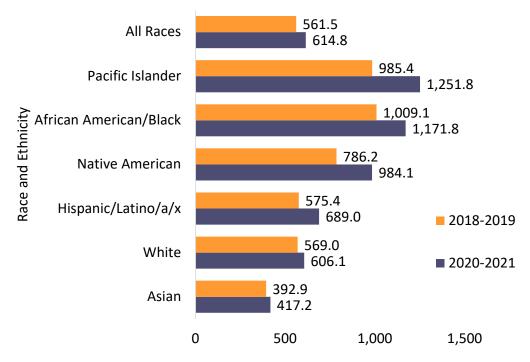

All-Cause Mortality Rate by Race and Ethnicity in Alameda County, 2018-2019 and 2020-2021

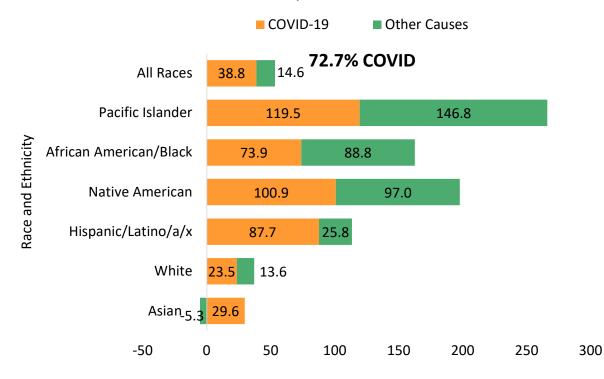

## Mortality increased in 2020-2021, exacerbating racial/ethnic disparities

Most (73%) of the overall increase in the death rate in Alameda County was due to COVID-19. Pacific Islander, African American/Black, and Native American people had large increases in mortality due to COVID-19 and due to other causes.

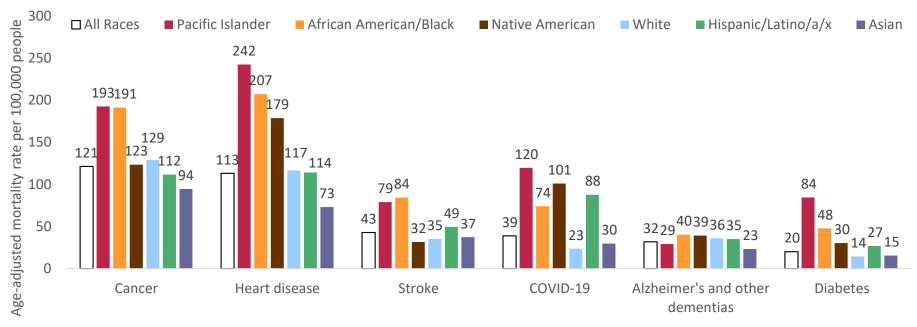

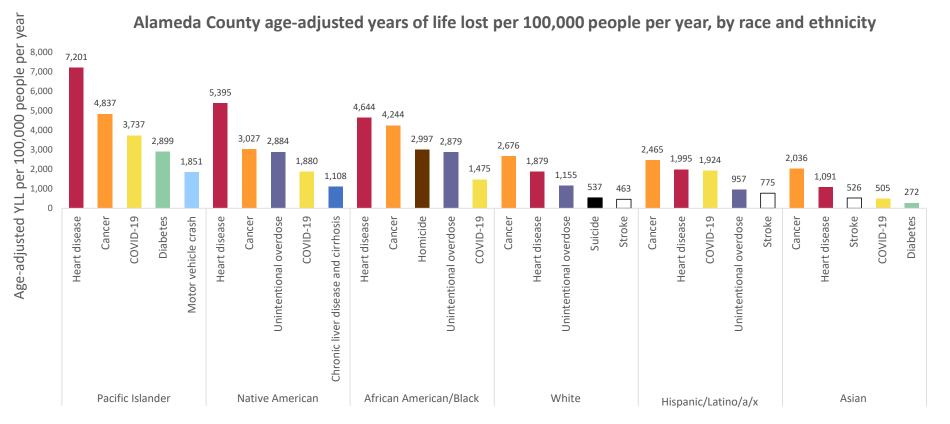

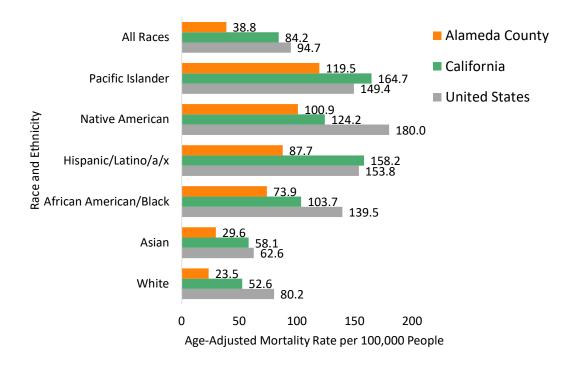

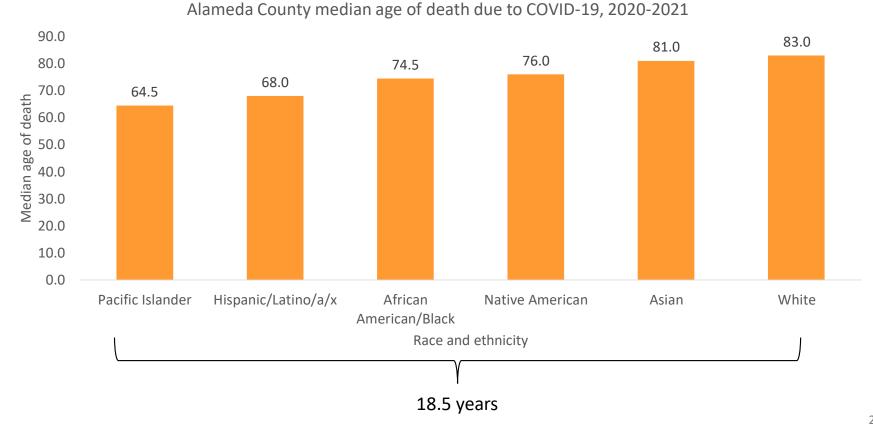

Alameda County had an ageadjusted COVID-19 death rate that was 41% the age-adjusted COVID-19 death rate in the United States and 46% the ageadjusted COVID-19 death rate in California. The age-adjusted COVID-19 death rate was lower in Alameda County than in California and the United States for each race and ethnicity.

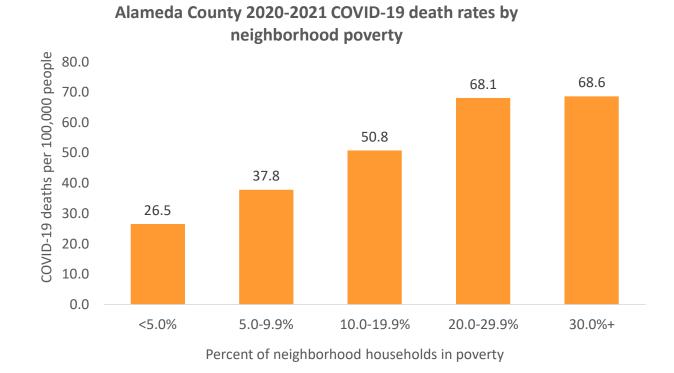

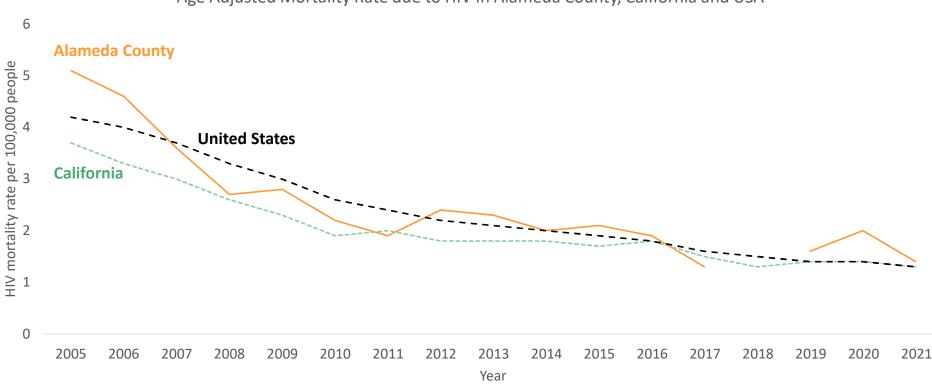

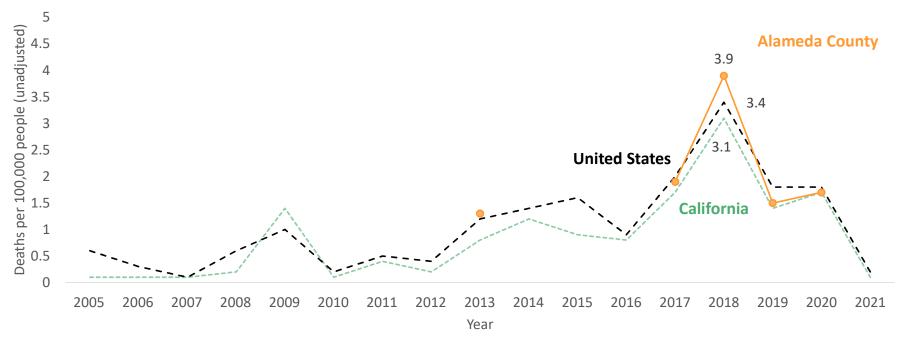


### HIV mortality has declined over time in Alameda County, California, and the United States

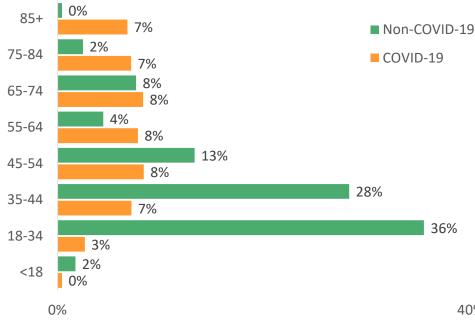


Influenza deaths per 100,000 people in Alameda County, California, and the United States

#### There were increases in deaths at young ages 2017-2019 to 2020-2021 in Alameda County, primarily due to non-COVID causes

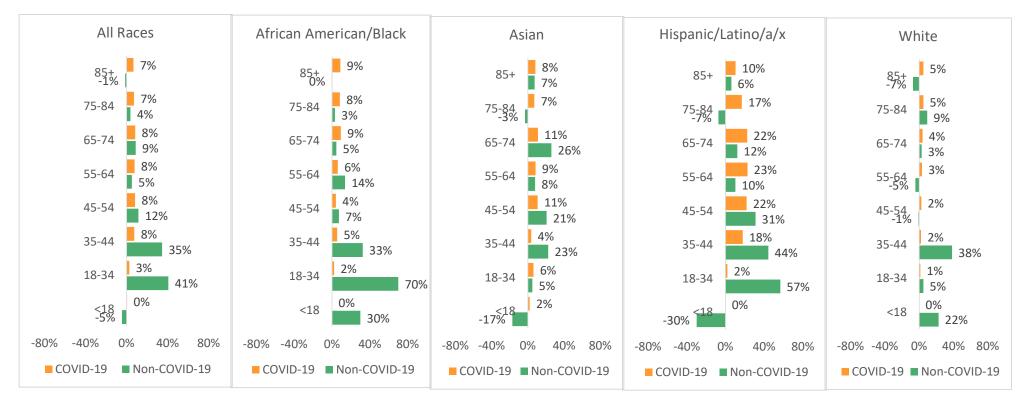
Percent change in deaths due to COVID-19 and due to other causes from 2018-2019 to 2020-2021, by age group

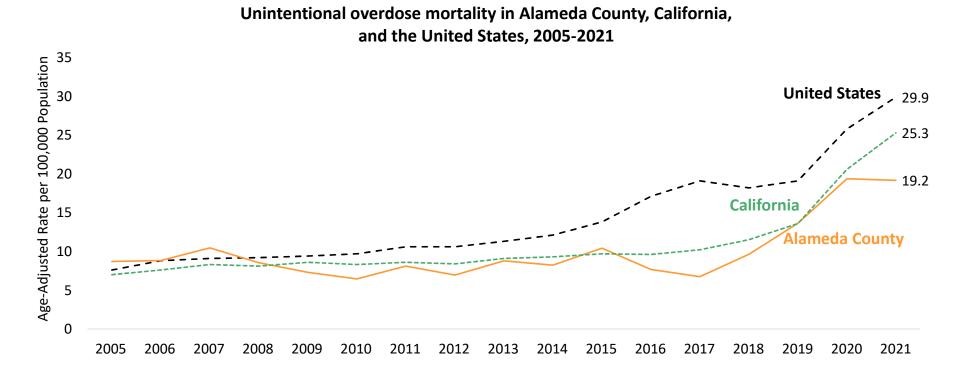

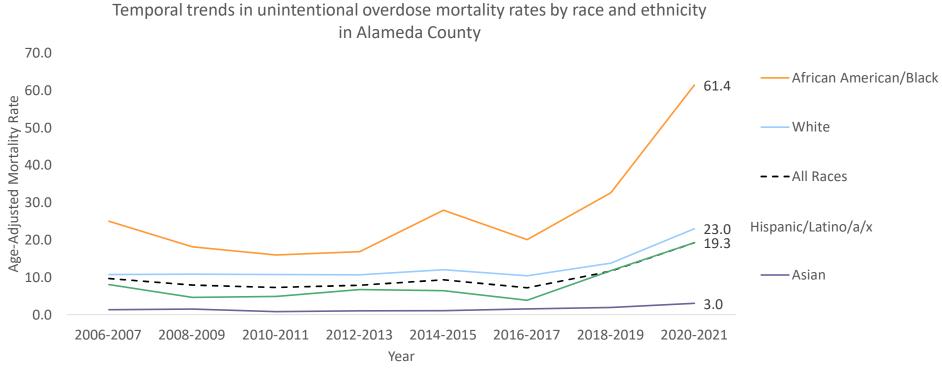

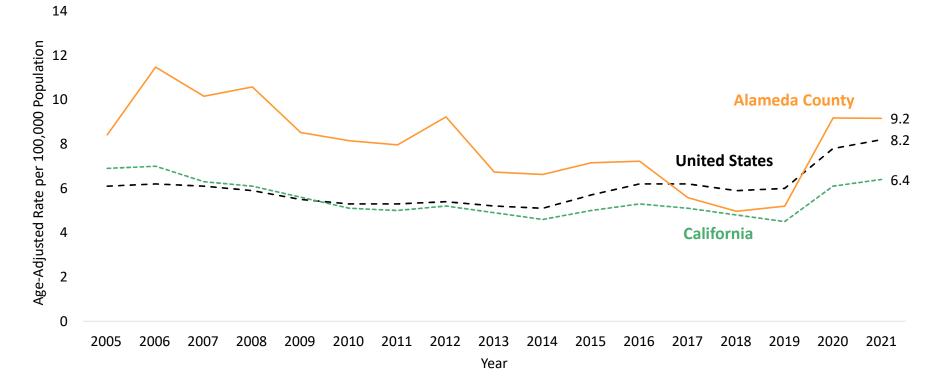

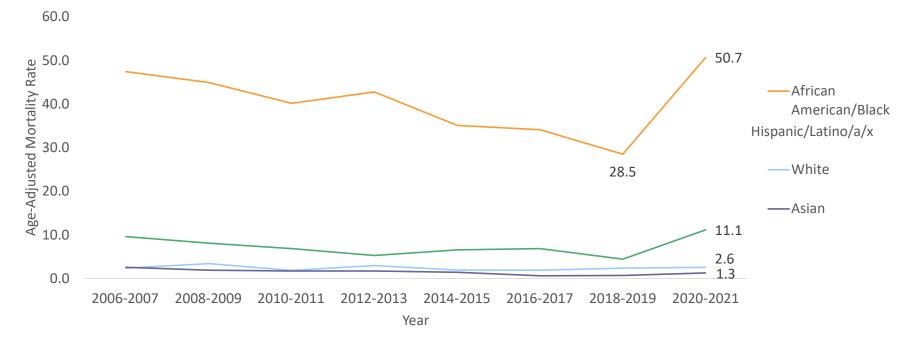

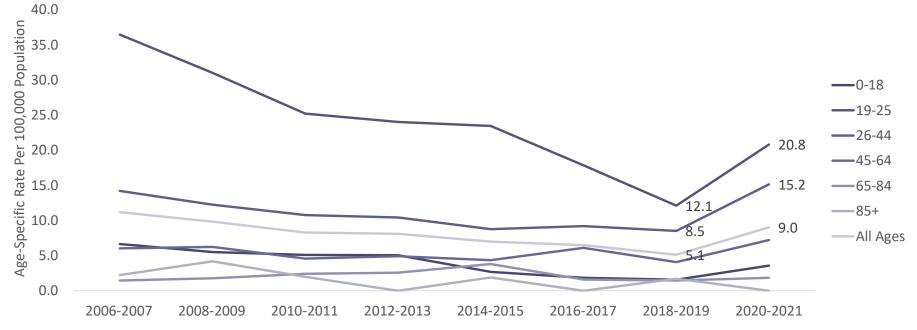
Temporal trends in homicide mortality rates by race and ethnicity in Alameda County

### Increase in homicide at young ages in Alameda County in 2020-2021

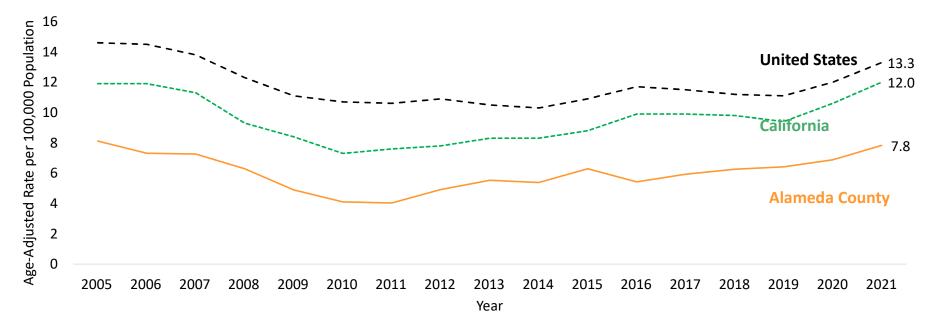

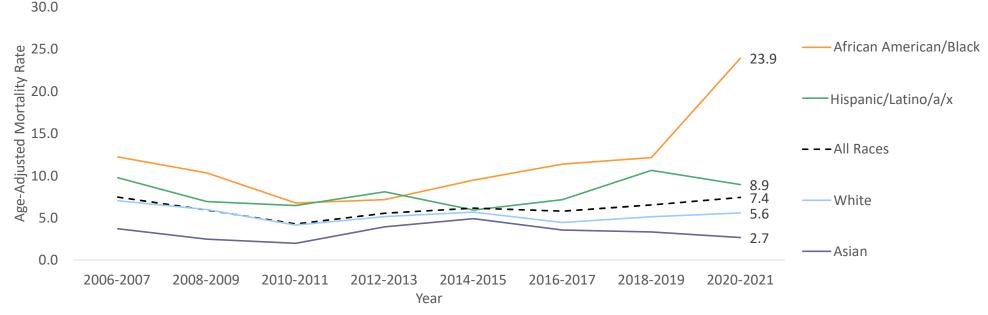
Motor vehicle traffic mortality rate in Alameda County, California, and the United States, 2005-2021

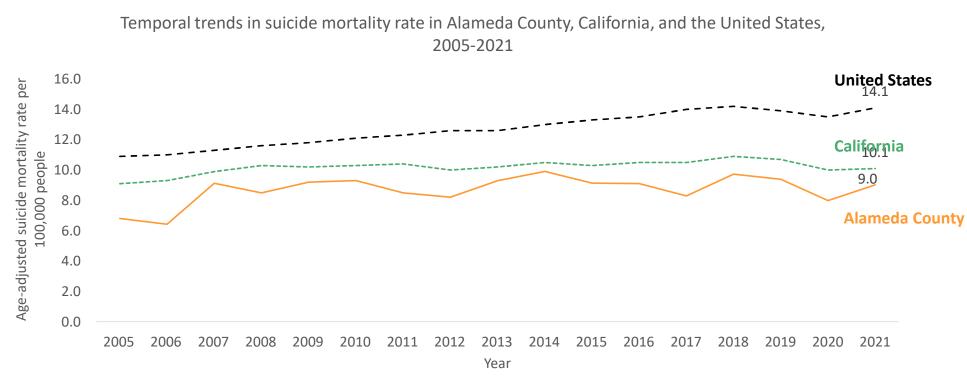

Temporal trends in motor vehicle crash mortality rates by race and ethnicity in Alameda County



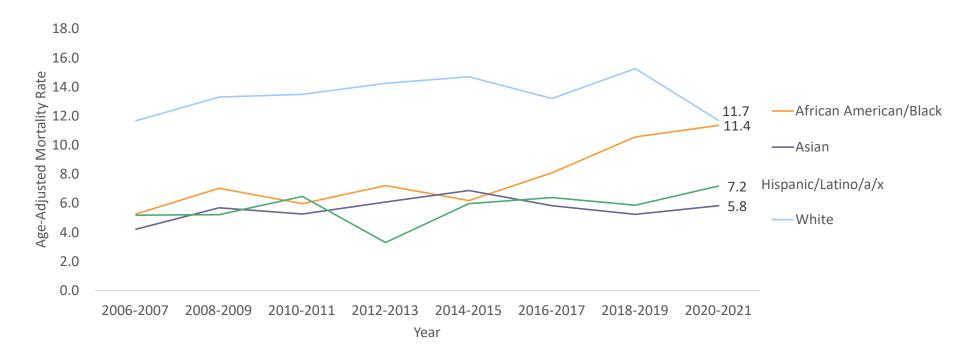

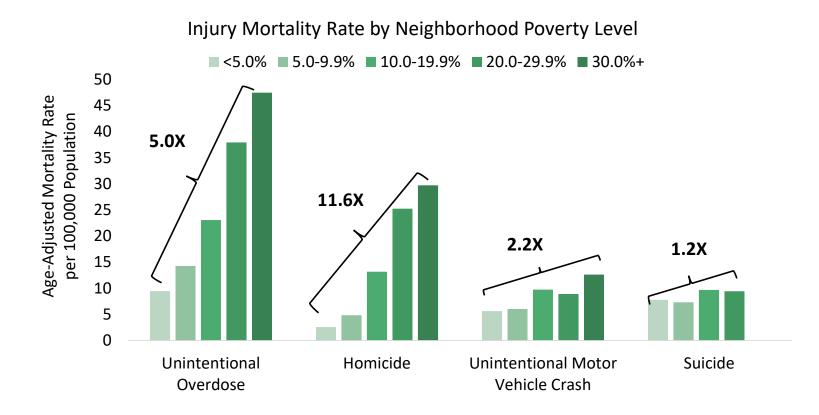

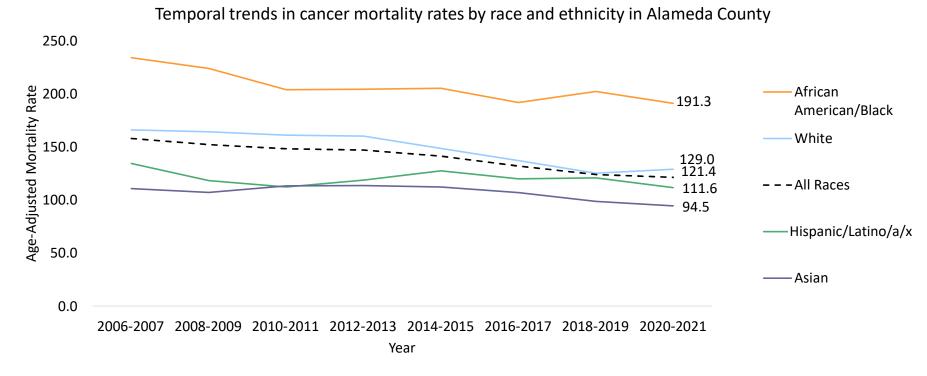

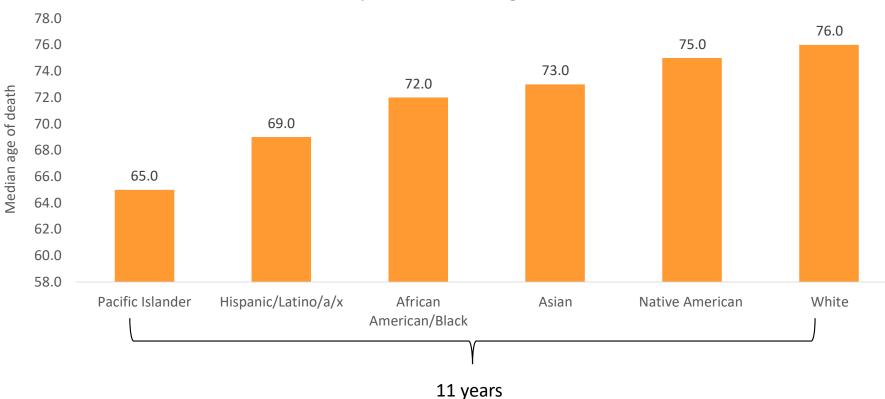

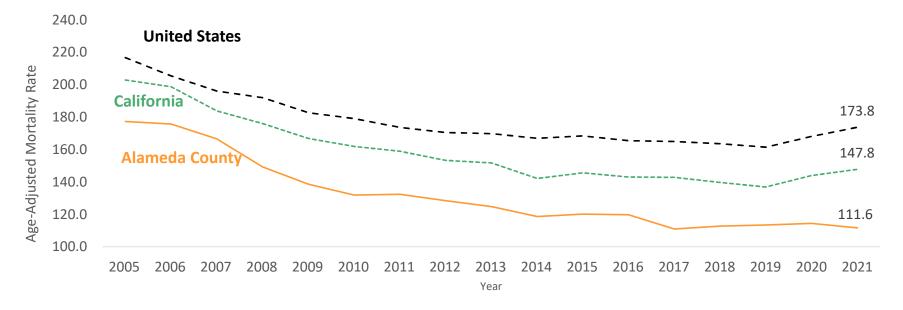

Racial and ethnic disparities in median age of death due to cancer

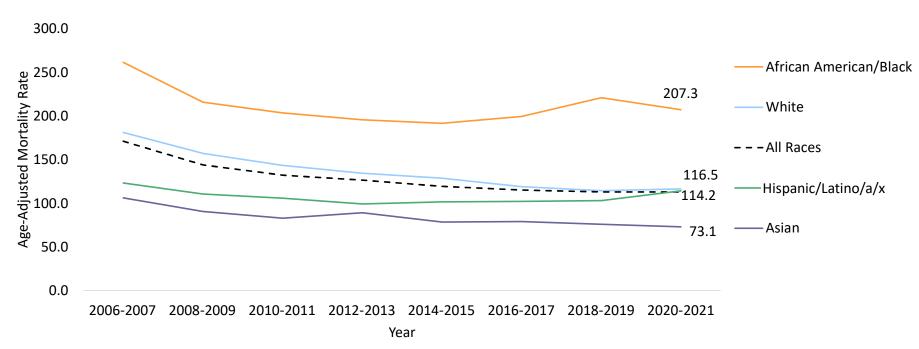

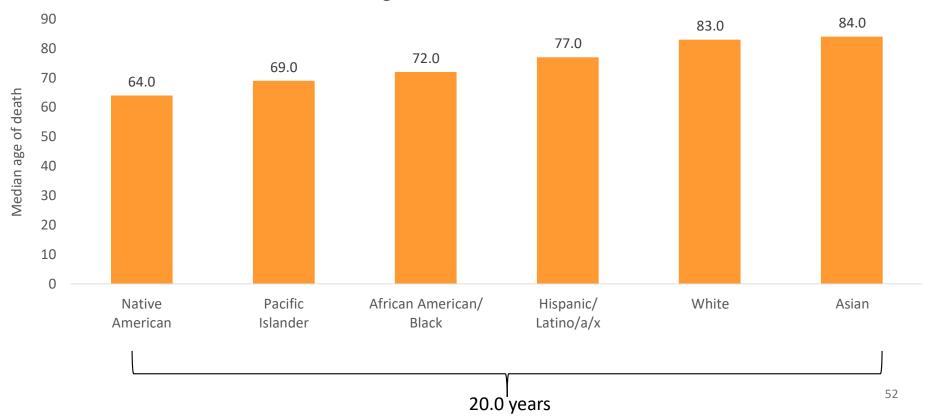

Temporal trends in heart disease mortality rates by race and ethnicity in Alameda County

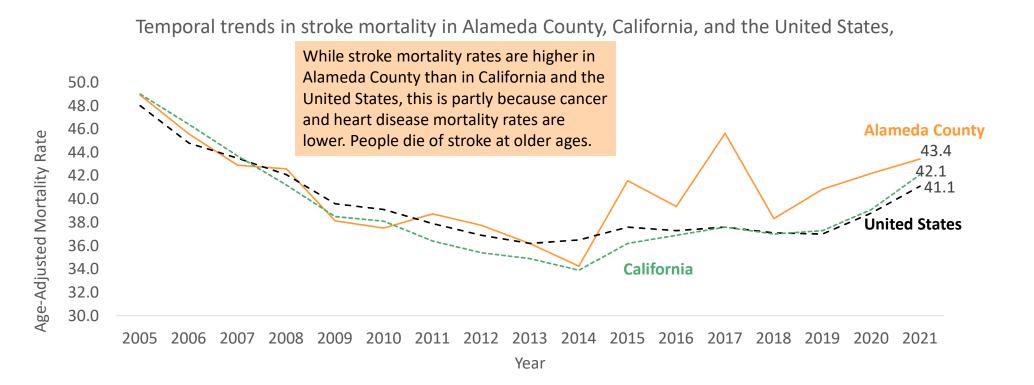

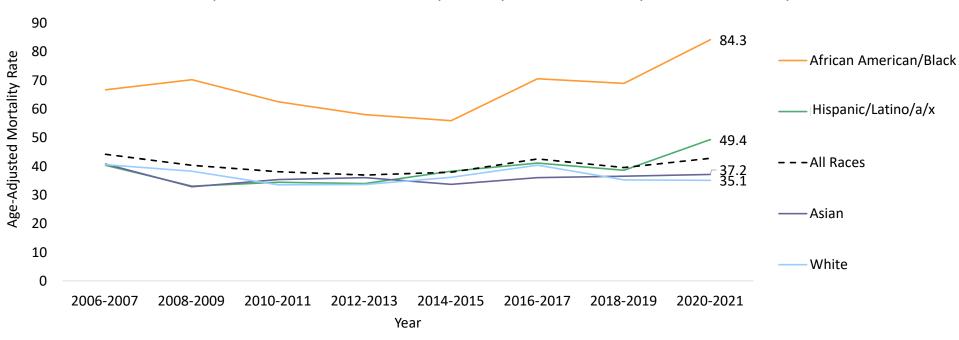


Median age at death due to Heart Disease

#### While stroke mortality is consistent over time in Alameda County, racial and ethnic disparities in stroke mortality persist and African American/Black stroke mortality is increasing

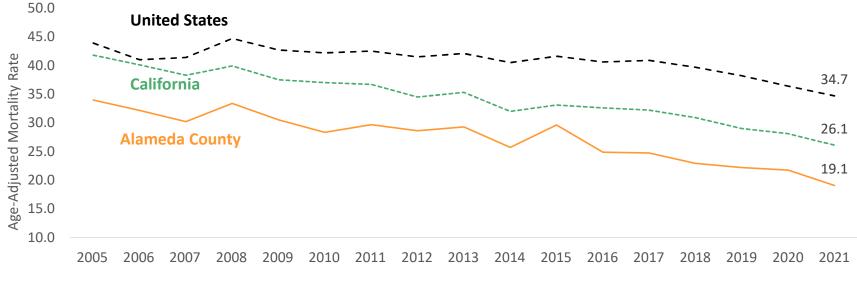


Temporal trends in stroke mortality rates by race and ethnicity in Alameda County

Temporal trends in age-adjusted chronic lower respiratory disease mortality in Alameda County, California and the United States, 2005-2021

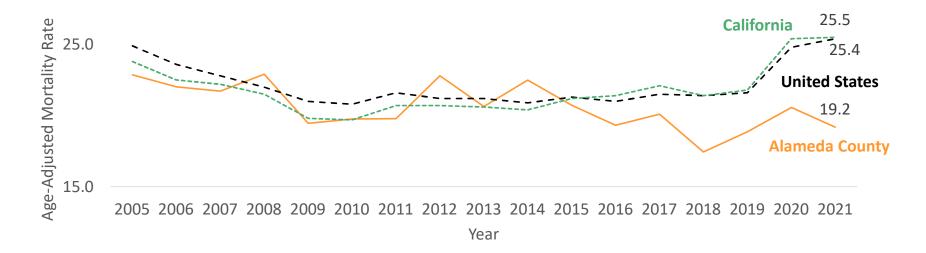

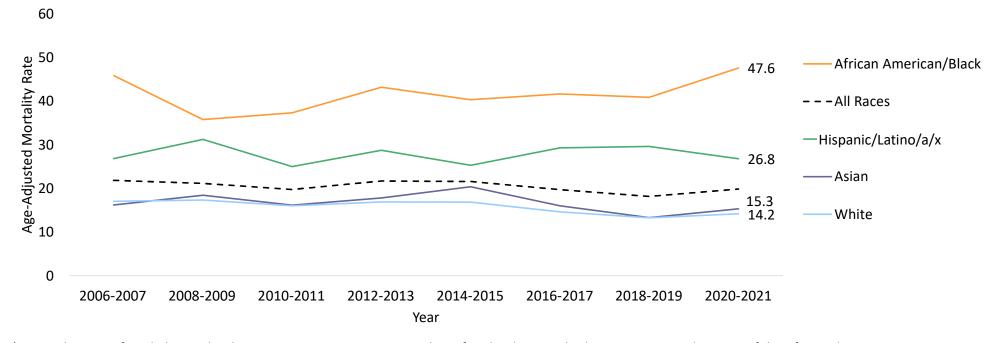

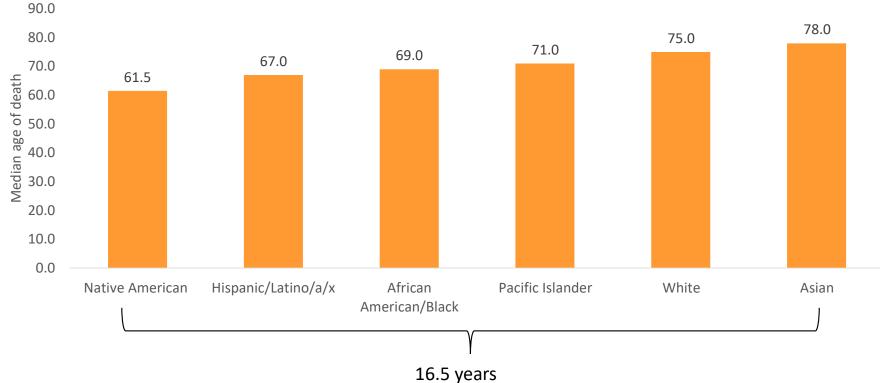

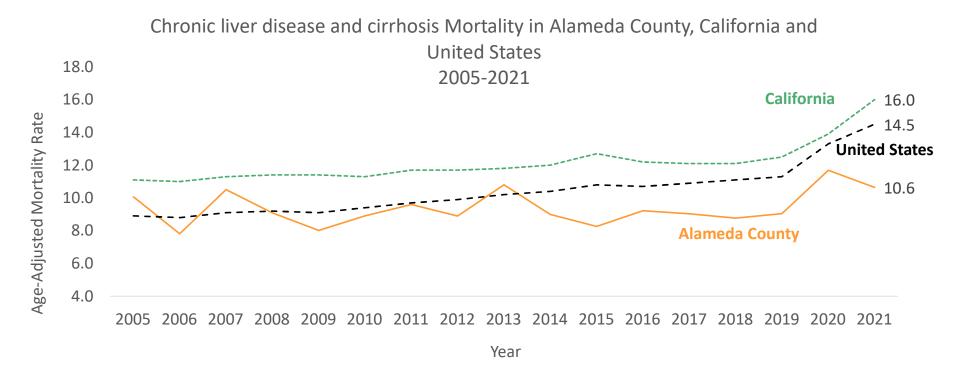

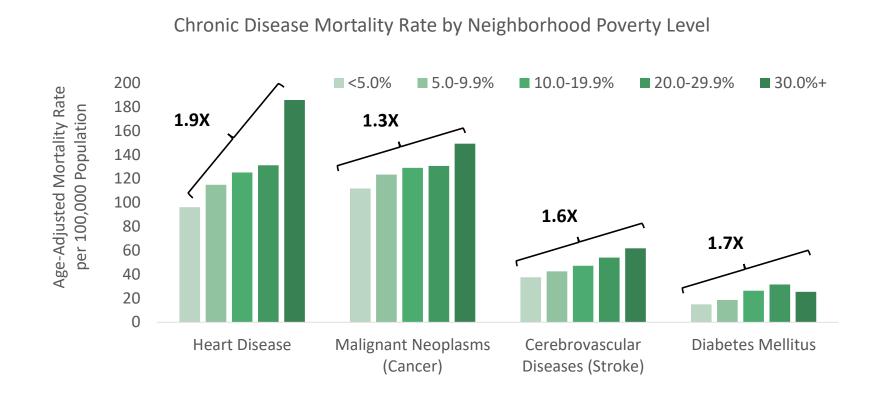


Racial and ethnic disparities in median age of death due to diabetes

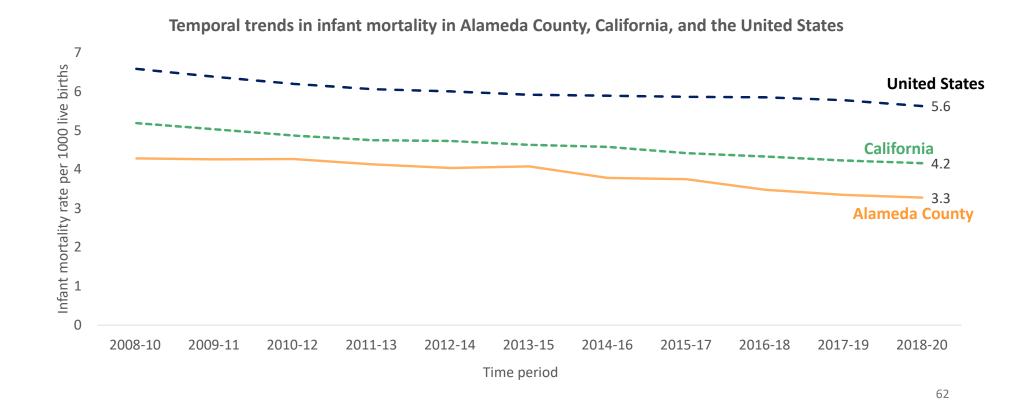

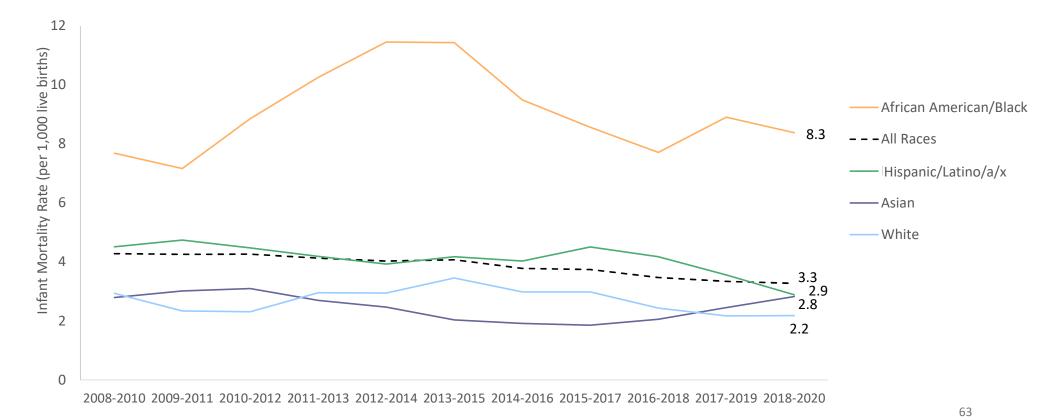

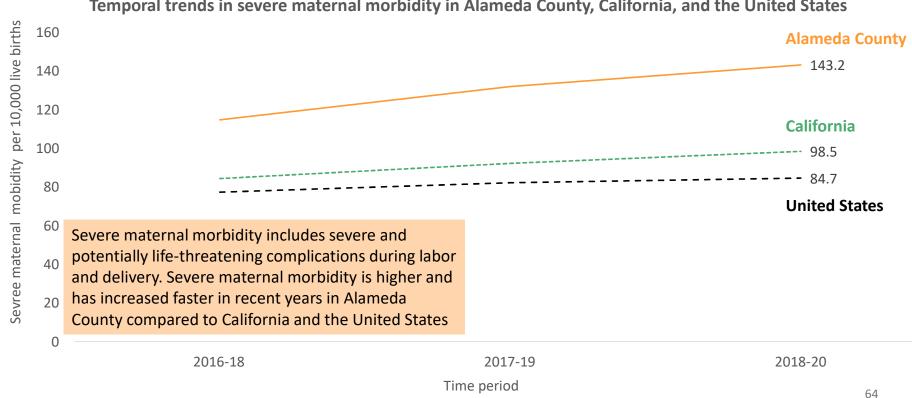

## Persistent racial disparities in infant mortality in Alameda County

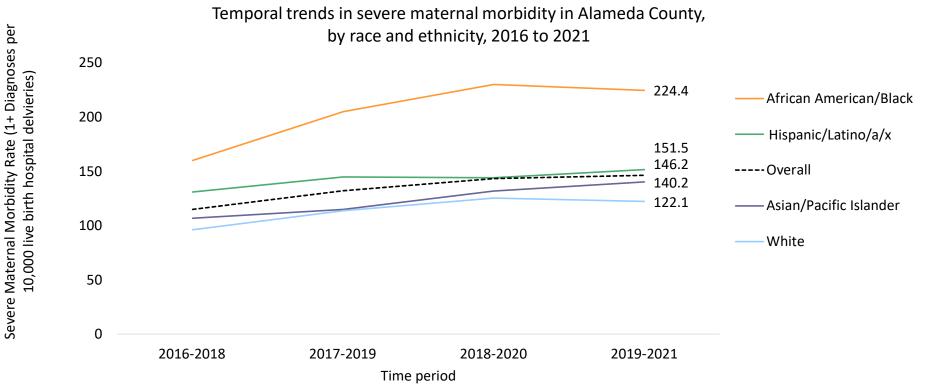


#### Severe maternal morbidity rate is higher in Alameda County than in California and the United States, and increasing across settings
