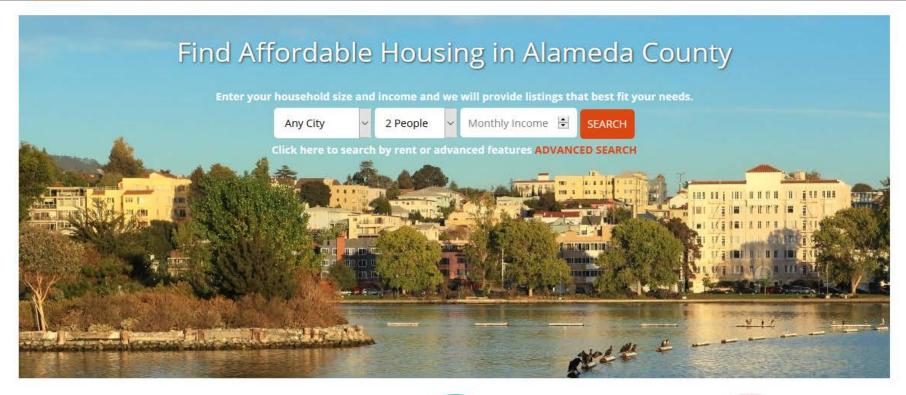

TYPES OF MARKET RATE HOUSING

APARTMENTS, DUPLEXES, and HOUSES managed by a private landlord or a property management company. Average rent for a two-bedroom - \$2,103.

SHARES and room rentals includes all housing which is shared with others. It includes rooms for rent, board and cares, sober living environments. Shared housing is a good way for many people with limited income to secure housing while waiting for affordable housing opportunities. Average rent: 1,000.

BEDS provide a rented bed in a room with others, from 2 to more individuals per room. Rent range - \$650.

BOARD and CARES are shared housing with more than one person per room that provide meals. It is usually designated for individuals with some type of disability. Average rent: \$900.

TYPES OF AFFORDABLE HOUSING

SUBSIDIZED BUILDINGS these building can be subsidized be multiple types of funding sources such as HOPWA (Housing Opportunities for People with AIDS), mental health units, developmentally and physical disabilities units.

BELOW MARKET RATE BUILDINGS are units that are partially funded through other funding sources and the tenant only pays a percentage of the rent.

SECTION 8:

Section 8 is a HUD program where participants (basically) pay 30% of their income towards rent, and the Housing Authority pays the remainder. Depending on the jurisdiction, the waiting lists for Section 8 maybe years long. Most jurisdictions Lists will be closed until vouchers are available.

The waitlists for most affordable apartments are up to 5 years wait or more. Waitlists for Vouchers in Alameda County can be 10 years or more.

Apply to lots of places, it's free. Call 2-1-1 or search the website every month for new open waiting lists.

Keep track of where you apply!

Have a stable mailing address, rent a P.O. Box, if needed.

Once every 2 months call the property manager to update your contact info and confirm that your name is still on the list.

Work on credit and background issues before they screen you. You will have several years.
