RCEB Services for Adult Individuals

Adult Day Centers/Program

There are several options for Adult Clients to go to during the day. In these programs, Adult Clients learn new skills, socialize, and have their care needs met. Some of the programs may specialize in various needs such as:

- Community Integration
- Creative Arts
- Health care Needs

Mobility Training

Services to help Clients learn to use public transportation in their community. This can help increase independence in the community.

Employment Programs

- There are several services that focus in the areas of helping Adult Clients obtain employment. There are various levels of support to meet Client's employment needs. Some of the employment services may include the following:
- * Day programs that offer employment and training
- * Group-Focused Employment Services through DOR
- * Individualized Employment Services (PIP)

Independent Living Services

Functional skills training for Adult Clients to acquire or maintain skills to live independently in his or her own home/apartment. Services may be provided in a home of a parent, family member, or other person.

Support Living Services

Services provided to Clients who live on their own who may need up to 24hour support.

Housing Support Services

- Services may be provided to Clients to assist them with living on their own. Some of these services may include:
- * Accessibility Services
- * Payee Services
- * Parenting Support Services

Health Care Facilities

Facilities that provide skilled nursing services and inpatient care to Clients who would not be able to live on their own or in a care home due to the severity of their physical or mental care needs.

Supplemental Support Program

- Additional staff that are added to a Client's support system when they are in crisis or need additional supports to continue using the services they are receiving. These services are typically in place temporarily until the client is no longer in need. These supports may be used in the following areas:
- * Community
- * Day Program
- * Residential

Pharmaceutical Services

Services that allow Regional Center of the East Bay to purchase medications for Clients when they are unable to access health care insurance.

Out-of-Home Respite Services

Services that provide a break to the parents or a caregiver person from the daily care needs of a Client. This respite occurs outside of the family home.

Respite Services - In-Home

Services provided in the family home that enable the parents or a caregiver or a family member to take a break from the daily care needs of the Client.

Residential Care Homes

- Care homes that provide a safe place for Clients to live. They are licensed homes that have 24-hour support staff. There are several different kinds of care homes that support the unique of each Client. Some of these homes may include:
- * Behavioral care needs
- * Children and Adult Care Homes
- * Elder Care Needs
- * Medical Care Needs

Behavior Management Services

Services that provide a various of health care professionals to address behavioral challenges in various settings. Services to train the Client's parents and caregiver person that can assist the Client to improve his or her behavior.

Crisis Response Project

Crisis support teams who can mobilize in the community when a Client is in short-term behavioral crisis.

Durable Medical Equipment

- Special medical equipment and medical related supplies for Client' medical care needs. These products may include the following:
- * Diapers * Eyewear
- Mobility equipment such as walkers and wheelchairs
- * Nutritional supplies
- * Dental checkup (Need denial letter from Medi-Cal)
- * Positioning and adaptive equipment

Specialized Transportation

- Regional Center of the East Bay offers a various of options to help Clients access the community when they are unable to do so on their own. Some of these options may include:
- * Family member paid transportation (Voucher)
- Non-medical transportation
- * Public transportation Para Transit

Translation/Interpreter Services

Services to help Clients and their family members communicate when they speak a language other than English.

Self-Determination Service

A new program options for Adult Clients that provides freedom, control, and responsibility in choosing services an supports to help meet their needs.

Competency Training Service

Service provided to Client(s) who have been arrested and charged with a crime to see if they can become competent to stand trial. If the training can restore competency, the Client(s) can continue with their case. If not, the Client(s) waits usually in jail, until an opening occurs at Porterville Development Center.
