This year's 2014 Statewide Medical and Health Exercise is designed to build upon our medical and public health community based capability and capacity for a disaster-related healthcare response.

The vision for our statewide exercise is for partners collaboration based on using an objective-driven focus. Exercise partners will work across organization/agency/disciplines to leverage commonalities in response to a wide scale public health emergency. Planning efforts promote options for customization of the exercise to meet everyone's needs. Healthcare partners, first responders and other stakeholders that plan to participate in the 2014 California Statewide Medical and Health Exercise should complete the participation form found on the following page.

- The Alameda County EOC will be activated and include key staff from the Public Health Department, Emergency Medical Services, Environmental Health Services, Behavioral Health Services and General Service Agency.
- The Health Care Services Agency DOC will be activated, and will be following an infectious disease ICS structure.
- Homeland Security Exercise Evaluation Program Guidelines will be followed.
- The Exercise Planning Team will develop county wide overarching objectives for all participants and exercise play. As in past years, participating agencies are encouraged to develop objectives to support their organization.
