
### Why do we focus on health equity?

### **Our Mission**

To work in partnership with the community to **ensure the optimal health and well being of ALL people** through a dynamic and responsive process respecting the diversity of the community and challenging us to provide for present and future generations.

### County Health Rankings: Alameda County

- Ranked 21 out of 56 CA counties for health outcomes
- Ranked 19<sup>th</sup> for health factors overall
- Ranked 24<sup>th</sup> for social and economic factors specifically
  - Unemployment:
    - 11.3% in AC vs. 12.4% in CA overall
  - Children in Poverty:
    - 17% in AC vs. 22% in CA overall



# Race, Place, and Income impact health

#### Compared to a White child in the affluent Oakland Hills, an African American born in West Oakland is...

**1.5 times** more likely to be born premature or low birth weight

**2.5 times** more likely to be behind in vaccinations

**5 times** more likely to be hospitalized for diabetes

**7 times** more likely to be born into poverty **4 times** less likely to read at grade level

**2 times** more likely to die of heart disease

INFANT CHILD ADULT

**Cumulative impact:** 15 year difference in life expectancy





### **Barrier to Health:**

## Lack of Financial Services & Credit

- \$3.89 million is stripped from Oakland families each year through payday loans\*
  - Predatory services are clustered in our low-income communities, mainstream banks moving out
- Lending to small businesses in lower-income neighborhoods dropped by 70% from 2007-2009

## **Creating Access:** Alameda County Prosperity Project

Our Roadmaps project aims to ensure that all residents, regardless of race or place of residence, can build the wealth and economic security necessary to lead a long and healthy life.



### **Prosperity through...**

#### Policy

Responsible Banking policies leverage local government banking relationships to expand access to financial products, small business loans and other services in underserved communities.

#### Education

The Savvy Consumer Toolkit uses popular education techniques to increase resident capacity to navigate the landscape of predatory products while still meeting family needs.

#### Practice

Integrating the Savvy Consumer Toolkit, other financial tools, and policy activities into existing health programs, especially home-visits to new families, will improve health outcomes.

Responding to emerging issues



- Field community and government agency requests
- Assess health equity impacts using our "Health Equity Policy Assessment Tool"
- Example:
  - Oakland Army Base Redevelopment environmental health and air quality standards

### Successes include...

- Vacant Property Registration Ordinance
  - Netted \$1.6 million for Oakland in 18 months
- Proactive Rental Inspection proposal
  - Approved by Council in Sept 2012
  - Pipeline project
- General Plan Health Element
  - Ashland/Cherryland
- Strong collaboration with community
